This is an interdisciplinary series that reviews and critiques individual and group performance of trauma cases. It allows the team to debrief the cases, discuss changes in patient care and/or access to specific medical resources or trauma systems that might lead to improvement in practice.

### **Objectives:**

- 1 Identify team problems encountered in practice or those identified by the presence of poor or unexpectedly poor patient outcomes.
- 2 Discuss options for differential diagnosis, treatment and management, citing appropriate resources and/or guidelines for evidence-based care.
- 3 Implement new standards and practices related to the care of the trauma patient.
- 4 Identify social determinants that affect patient care for trauma patients
- 5 Identify practice improvements that can be made to improve healthcare quality and safety of the trauma patient
- 6 Integrate a multidisciplinary approach into the development of plan of care
- 7 Review clinical guidelines as a team to identify areas of improvement for application to clinical practice
