Live Activity

Purpose:

This is an interdisciplinary case conference that allows the Avera McKennan Trauma Department to review patient cases transported by the Care flight staff that warrant review of invasive procedures, deaths, or case of interest. This provides the team an opportunity to debrief the cases, discuss changes in patient care, and/or access to medical resources or trauma systems that would lead to improved practices.

Objectives:

- 1 Implement new standards and practices related to the care of the trauma patient
- 2 Review clinical guidelines to identify areas of improvement for application to clinical practice.
- 3 Discuss options for treatment and management, citing appropriate resources and/or guidelines for evidenced-based care.
- 4 Identify social determinants that affect patient care for the trauma patient
- 5 Identify practice improvements that can be made to improve healthcare quality and safety issues related to the care of the trauma patient
- 6 Integrate a multidisciplinary approach into the development of plan of care
- 7 Develop strategies and a team approach to prevent complications with the critically ill patients
