Now, we are excited to let you know that we have submitted our application for Joint Accreditation and our interview is scheduled for September 21st!

Joint Accreditation offers the ability to award additional credits such as ACPE national pharmacy credits and ACE national social work credits. Application Update - Update Disclosure button

A new button "Update Missing Disclosures" has been added to the Planners & Faculty page in the Application. This can be used to refresh to see if Committee/Faculty have completed a disclosure.
