

2021 Avera vLEAD Leadership Series: Exploring Values Through a Lakota Lens

Program Goal

One core competency for all leaders is having a clear sense of their values - both personally and organizationally - and how their values drive vision and purpose. This session invites leaders to reflect on their own values and Avera's values as they hear from Avera's Director of Tribal Relations, JR LaPlante, a member of the Cheyenne River Sioux Tribe, on an exploration of the seven sacred values of the Lakota people.

Objectives

- 1 Discuss how successful teams and high quality leadership lead to an improved health care delivery system.
- 2 Articulate at least three of the sacred values of the Lakota people.
- 3 Reflect on their own values and how they influence their leadership.
- 4 Understand the similarities between Lakota sacred values and Avera's values.

Outcome

80% of learners will self-report an increase in knowledge of the tools utilized in order to effectively lead their teams by the end of the activity.
