The Perinatal Nurse Practicum is a 2 day course providing education for the registered nurse regarding care of the woman and her infant throughout pregnancy, birth, and postpartum. Content for the Perinatal Nurse Practicum includes the following areas: maternal physiology, fetal heart rate pattern review, care of the woman during labor and postpartum, preterm labor, obstetric emergencies, hypertensive disorders or pregnancy, intrapartum and postpartum care of the diabetic woman and her infant, postpartum complications, care of the newborn, infant security, and infant loss/bereavement.
