Program Goal

This course offers learners a case study approach to learning about drug overdoses in the emergency setting. As drug overdose set all time records within the country, this course outlines the care and treatment. The learners will learn how to utilize the MATTERS acronym to assess, test and treat patients with a suspected drug overdose. Drugs to be covered include, but are not limited to alcohol, opioids, heroin, and methamphetamines'

Objectives

- 1 Identify a generalized approach to the assessment and care of the patient who has overdosed
- 2 Identify the signs and symptoms of alcohol intoxication and withdrawal and medical management of patient
- 3 Identify signs and symptoms of opioid intoxication and medical management of patient
- 4 Identify signs and symptoms of stimulant intoxication and medical management of patient
- 5 Recognize other common drugs of abuse and signs and symptoms of overdose

Outcome

100 % of the healthcare team will demonstrate knowledge of the care and treatment of the overdose patient by passing post-test with score of $\geq 80\%$.
