Program Goal

Sharing Difficult Information during a Virtual Visit can be done in a very compassionate, patient centered way. It isn't necessarily what you have to say-- it is how you say it, whether you are face to face or over a camera. In any situation, there are some basic practices and language that should be used to ensure that the patient and family feel informed and listened to. This course will provide the learner with knowledge to navigate through a difficult conversation with a patient and family via virtual care.

- 1 Describe the key components of navigating a difficult conversation in a virtual setting
- 2 Discuss key components of preparing for a difficult conversation
- 3 Identify steps to build rapport with the patient
- 4 Recognize the importance of assessing patient/family knowledge of the situation as well as sharing their knowledge of the situation
- 5 Identify how to conclude a difficult conversation

Outcome

100 % of the healthcare team will demonstrate increased knowledge in navigating a difficult conversation with patients and families in a virtual setting regarding care and prognosis by passing post-test with score of $\geq 80\%$.
