eCare Senior Care: Amylotrophic Lateral Sclerosis or Lou Gehrigs Disease

<u>Program Goal:</u> Amylotrophic Lateral Sclerosis (ALS) is one of multiple degenerative motor neuron diseases that are clinically defined, based on the involvement of upper and lower motor neurons and is the most common form of motor neuron disease. ALS is also known as Lou Gehrig's disease, after the famous New York Yankee base ball player who was affected with the disorder.
