Purpose

- diagnosis and the impact of implementing patient specific interventions to enhance outcomes and quality of cancer care.
- 7 Discuss the process to implement an opioid withdrawal assessment tool in and acute hospital setting
- 8 Describe the improvement of peer feedback education on the confidence and quality of peer feedback amongst practicing hospital nurses.

Outcome

90% of nurse leaders and clinicians will self-report an increase in knowledge of the unique stress of the COVID-19 pandemic and implement strategies to improve quality patient care by the end of the session.
